Installation Instructions

1. Close all open ETS applications (ETS)
2. Click or Copy the URL into your web browser
 - <https://ets.fdic.gov/ets-freddy/>
3. Click "Download ETS-FREDDY"
4. Select Run
 - NOTE: Additional instructions for installation/security pop are provided in the addendum
5. After security scan completes (in Internet Explorer), click Install in new popup that appears
6. Installation completes when the ETS-FREDDY application opens

What is ETS-FREDDY

ETS-FREDDY is a pre-requisite and post-installation system checker for ETS. It will check system requirements, installed programs, and database information to ensure that the user has the necessary setup to run ETS. In addition, it can also try to fix certain problems that it finds if the user has the necessary permissions. There is also a reference section that gives access to relevant websites and programs as well as a tools section which has some automated system and database processes to assist users when troubleshooting ETS issues.
